<b>P1</b>	OBC certificate to be provided in the Govt. of India format and issued by an appropriate authority on or after 1.4.2021
<b>P2</b>	SC/ST/PwBD certificate to be provided in the Govt. of India format
<b>P3</b>	Experience certificate from all the employers to be provided duly indicating the period of employment in each grade/post within the same organisation
<b>P4</b>	Discharge certificate / NOC to be provided to obtain relaxation entitled for Ex-servicemen
<b>P5</b>	All the documents to be provided
<b>P6</b>	PG Diploma Certificate/other proof indicating that the duration of the diploma is of two years should be provided (one year diploma will not be considered as the essential qualification)
