Recruitment of School of diagnostic innovation in Biodesign Fellows (SiB Fellows)

Recruitment Notice No. THS/RN/31/2023

Translational Health Science and Technology Institute (THSTI) is an autonomous institute of the Department of Biotechnology (DBT), Ministry of Science & Technology, Government of India. THSTI is a part of the interdisciplinary Biotechnology Science Cluster at Faridabad, Haryana in the National Capital Region (NCR). The institution is a dynamic enterprise with a mission to conduct innovative translational research and to develop research collaborations across disciplines and professions to translate concepts into products to improve human health.

THSTI has built several inter-institutional collaborations and connectivity with industry supported by well-trained teams of research and laboratory staff. THSTI has established various centres namely (a) Centre for Maternal and Child Health, (b) Centre for Viral Therapeutics and Vaccines (c) Centre for Tuberculosis Research (d) Centre for Microbial Research, (e) Centre for Immunobiology and Immunotherapy (f) Centre for Drug Discovery (g) Clinical Development Services Agency (h) Computational and Mathematical Biology Centre (i) Centre for Bio-design and Diagnostics. These centres are strengthened by many core facilities viz. Bioassay Laboratory, Biorepository, Biosafety Level -3 Lab, Data Management Centre, Immunology Core laboratory, Multi-OMICS facility, Experimental Animal Facility, Vaccine design and Development facility, School of Innovation in Biodesign etc that serve as huge resources for the research programmes of THSTI and also the National Capital Region Biotech Science Cluster and other academic and industrial partners.

School of diagnostic innovation in Biodesign (SiB) has been created at Translational Health Science and Technology Institute (THSTI) by Department of Biotechnology (DBT), Ministry of Science and Technology, Government of India. This fellowship program is being implemented at THSTI in collaboration with leading institutions in the country viz. Indian Institute of Technology-Madras (IITM), Christian Medical College, Vellore, PGI-Chandigarh and Venture Centre- Pune. The focus of this program is on medtech innovations for the development of affordable and accessible medical diagnostic technologies.

'SiB' has been a very successful flagship program of DBT which has led to development of more than 35 medtech products and 20 startups.

This call is open for the position of "**SiB Fellows**" at THSTI to work for innovation and product development in medical diagnostics.

The goal of the Fellowship is to foster a pool of social and science innovators in the Bio-design arena and to train them to become successful entrepreneurs. The fellows will be exposed to all

aspects of the development, validation, commercialization and use of diagnostics. The fellowship will run for a duration of twelve (12) months. The innovators and entrepreneurs trained via this program are expected to provide niche skills in the domain of diagnostics and enable India to attain its goal of "Aatma Nirbhar Bharat".

The program is looking for millennials with passion for technology innovation and requisite skills for receiving training in clinical immersion, product innovation and entrepreneurship.

This recruitment is to fill up the vacancies under the project entitled "Inter-Institutional School of Diagnostic Innovation in Bio-design (SIB): A fellowship program for building next generation pool of diagnostic innovators and entrepreneur".

Selection Criteria: The applications received will be screened based on the eligibility criteria mentioned above and content of the "Statement of purpose" (to be uploaded online along with application). The shortlisted candidates will be called for an interview in person at THSTI, Faridabad. The names of shortlisted candidates will be announced on our website. The dates for the interview will be announced later.

Final selection will be made based on the applicant's performance in the interview and the list of selected candidates will be published on the THSTI website.

GENERAL TERMS & CONDITIONS:

1. This is a short-term project based positions. The person appointed to this position will not have any claim for regularization of his/her employment.
2. All educational, professional and technical qualification should be from a recognized Board/University.
3. The experience requirement specified shall be experience acquired after obtaining the minimum educational qualifications required for the post.
4. Persons working in Govt. / PSUs/ autonomous bodies shall apply through proper channel or produce 'No Objection Certificate' at the time of interview.
5. The age limit, qualification, experience and other requirements may be relaxed at the discretion of the competent authority, in case of candidates who are otherwise suitable. In case candidates are not found suitable for the posts notified, they can be offered lower post / lower emoluments on the recommendation of the Selection Committee.
6. Age and other relaxations for direct recruits and departmental candidates:
 - a. By 5 years for candidates belonging to SC/ST community.
 - b. By 3 years for candidates belonging to OBC community.
 - c. For Persons with Benchmark Disabilities (PwBD) falling under the following categories:
 - (i) UR - 10 years
 - (ii) OBC - 13 years
 - (iii) SC/ST - 15 years
 - d. For Ex-servicemen up to the extent of service rendered in defence forces (Army, Navy & Air force) plus 3 years provided they have put in a minimum of 6 months attested service.
 - e. Age is relaxable for Government servants up to 5 years in accordance with the instructions or orders issued by the Central Government, from time to time.
 - f. There is no upper age limit for the Institute employees who are treated as departmental candidates.
7. Number of positions filled will be as per need and availability of the suitable candidates.
8. In case a large number of applications are received, screening will be done to limit the number of candidates to those possessing higher/relevant qualification and experience.
9. Number of vacancies may vary depending upon the requirement at the time of interview.
10. All results will be published on our website and all communications will be only through email, therefore the candidates are required to visit our website regularly.
11. All future communications will only be through email.
12. Canvassing false information in any form will be a disqualification.

- (iv) Intermediate certificate (equivalent to 12th Standard) / Mark sheet
- (v) Graduation/Diploma degree certificate / Mark sheet
- (vi) Post-Graduation degree/diploma (minimum duration 2 years) certificate & Mark sheet (if applicable)
- (vii) Relevant experience certificates
- (viii) Caste / Disability certificate in the format prescribed by the Govt. of India, if applicable
- (ix) A "Statement of purpose" in 1000 words in word format, describing aspiration of the candidate in technology innovation.
