**Terms & conditions: -**

1. The work shall be carried out as per direction & recommendation of the Engineer-In-Charge.
2. The rates are Net inclusive of all taxes; duties etc. and nothing Extra shall be paid.
3. Income Tax etc. will be deducted as applicable on the value of work done.
4. The deviation limit shall be  $\pm 10\%$ .
5. The contractor is required to follow all labour laws, Minimum Wages Act and other provision to labour welfare applicable from time to time. Nothing extra shall be paid for the same.
6. The work shall be executed without any loss/damage to THSTI properties etc.
7. The total work Included: -
  - I. Supply, Installation & Testing including removal of old power supply of fire alarm panel as per site requirement.
  - II. Rectification of all troubles occurred in the fire alarm panel and make the fire alarm panel proper functional as per site requirement.
  - III. Testing of the fire alarm panel after completion of work.
8. Any damages occur during the execution of work, the same should be rectified by the contractors on their own cost.

9. Contractor shall be fully responsible for safety of his workers and in case of any misshaping the entire responsibility shall be on the contractor.
10. The Contractor shall clean the site after completion of work in all.
11. The dismantled material shall be returned to THSTI if any.
12. The time of completion of the said work at THSTI is 10 days from the date of Issue of Work Order from the office.
13. Liquidated damages shall be lived on the Contractor @1% per week of delay to the maximum up to 10% of the contract value after expiry of completion period as stipulated in NIQ
14. The rates are inclusive of 1 Year warranty period.
15. Terms of Payment: 90 % of Contract Value after submission original invoice, Completion certificate, Delivery challan and test report if any against the Work.
16. 10% Security deposit on work done value shall be deducted from the bill which shall be refunded as below after satisfactory completion of work of warrantee period i.e. 1 Year.
