- BRIC-Translational Health Science and Technology Institute (THSTI) is an Institute of the Biotechnology Research and Innovation Council, Department of Biotechnology, Ministry of Science & Technology, Govt. of India. The institute is an integral part of the interdisciplinary NCR Biotech Science Cluster located at Faridabad, with the mission to conduct innovative translational research and to develop research collaborations across disciplines and professions to translate concepts into products to improve human health.
- The Medical Research Centre (MRC) at THSTI is being established with a clear mandate to conduct human studies that validate and advance laboratory discoveries. By translating pre-clinical findings into clinical applications, the MRC will focus on ensuring the safety, efficacy, and real-world impact of innovative therapies and medical products, paving the way for industry partnerships to scale these solutions effectively.
- In line with this vision, THSTI is establishing a state-of-the-art facility and program for Controlled Human Infection Studies (CHIS) at the upcoming MRC. CHIS are a specialized form of clinical research where healthy volunteers are intentionally exposed to a known quantity of an infectious agent, such as a virus, bacterium, or parasite, under carefully controlled conditions. These studies aim to deepen understanding of disease development and progression in the human body while accelerating the development of vaccines, treatments, and other critical public health interventions.

GENERAL TERMS & CONDITIONS:

- These are the short-term positions and extension will be granted subject to satisfactory performance of the incumbents and tenure of the project for which they are selected. Those appointed to these positions will not have any claim for regularization of their employment.
- All educational, professional and technical qualification should be from a recognized Board/University.
- The experience requirement specified above shall be the experience acquired after obtaining the minimum educational qualifications specified for the post. The candidates are required to satisfy themselves, before applying /appearing for the selection process, that they possess the minimum eligibility criteria as laid down in the recruitment advertisement. No query will be entertained with regard to eligibility criteria.
- The date of Interview of the respective post will be the **CRUCIAL DATE** for determining eligibility with regard to age, experience, essential qualification etc.
- Age and other relaxations for direct recruits and departmental candidates: 1. By five years for candidates belonging to SC/ST communities. 2. By three years for candidates belonging to OBC communities. 3. For Persons with Benchmark Disabilities (PwBD) falling under the following categories : (i) UR - ten years, ii) OBC - 13 years (iii) SC/ST - 15 4. Age is relaxable for Central

Government servants up to five years in accordance with the instructions or orders issued by the Central Government, from time-to-time. 5. Institute employees will get the age relaxation to the extent of the service rendered by them as on closing date of advertisement. 6. For Ex-servicemen upto the extent of service rendered in defence forces (Army, Navy & Air force) plus 3 years provided they have put in a minimum of 6 months attested service.
