Terms & conditions: -

- 1. The work shall be carried out as per manufacture recommendation and as per the direction of Engineer-In-Charge.
- 2. The rates are Net inclusive of all taxes; duties etc. and nothing Extra shall be paid.
- 3. Income Tax & D Vat etc. will be deducted as applicable on the value of work done.
- 4. The deviation limit shall be $\pm 10\%$.
- 5. The contractor is required to follow all labour laws, Minimum Wages Act and other provision to labour welfare applicable from time to time. Nothing extra shall be paid for the same.
- 6. The work shall be executed without any loss/damage to THSTI properties etc.
- 7. The total work Included: -
 - I. Installation of complete software at the respective location.
 - II. Execution of electrical work such as modification in wiring, dismantling/ replacement of existing module & control cards and other accessories as per site requirement.
 - III. Testing of the entire system should be done by the agency.
- 8. Any damages occur in the system/any other structure /places during the installation of software/system, the same should be rectified by the contractor's s on their own cost.
- 9. Contractor shall be fully responsible for safety of his workers and in case of any misshaping the entire responsibility shall be on the contractor.
- 10. The Contractor shall clean the site after completion of work in all.

- 11. The dismantled material shall be returned to THSTI if any.
- 12. The time of completion of the said work at THSTI is 15 days from the date of Issue of Work Order from the office.
- 13. Liquidated damages shall be lived on the Contractor @1% per week of delay to the maximum up to 10% of the contract value after expiry of completion period as stipulated in NIQ
- 14. The rates are inclusive of 1 Year warrantee period.
- 15. Terms of Payment: 90 % of Contract Value after Completion of Work
- 16. 10% Security deposit on work done value shall be deducted from the bill which shall be refunded as below after satisfactory completion of work of warrantee period i.e. 1 Year.
